Limited Product Warranty for GE Silicones* Enduris™ Roof Coating

Momentive Performance Materials Inc. ("Momentive") produces and sells GE Silicones Enduris roof coating (the "Product"). These Products offer a variety of physical characteristics. Specifically, Momentive warrants that the product selected for the project referenced above (the "Project") will, if properly stored, installed and applied as instructed on the Product Technical Data Sheet ("TDS") and/or Product Guide Specification, meet the physical characteristics as shown on the TDS for the Product in effect at the time of sale. Momentive's sole liability under this warranty is to provide material to replace that which is determined to not meet the physical characteristics as shown on the TDS. Project Owner is required to notify Momentive in writing at the address shown below, within 30 days of discovery of the alleged defect, and provide Momentive access to Project to inspect any areas with alleged defective product at any such time as may be reasonable.

Momentive does not warrant the design of the Project, nor the workmanship with which the Product is used or applied, nor the suitability or performance of any Project components, including substrates, other than the Product named above. The following conditions are specifically excluded from coverage under this Limited Product Warranty:

- 1. Damage to the Project from natural causes, such as lightning, earthquake, hurricane, tornado, hail, fire, wind or other events
- 2. Movement and settling of the building, building components or roof structure and assembly
- 3. Damage caused by plant or animal activity, such as birds, insects, or falling branches
- 4. Damage caused by humans, such as subsequent construction activity or damage from repeated foot traffic or tools
- 5. Damage as a result of poor design of the roof assembly or building
- 6. Condensation on the underside of the roof deck or components
- 7. Change in color or appearance as a result of dirt, dust, debris or growth of organic matter
- 8. Damage caused or made worse by of Owner's lack of roof maintenance or delay in reporting alleged defects to Momentive.



No other warranty except of title, shall be implied. Any tests designed to resolve any alleged breach of warranty shall be mutually agreed upon, and Momentive shall be notified of, and may be represented at, all such tests that may be made. The liability of Momentive (except as to title) arising out of the supplying of the said Product, or its use, whether on warranties, contract, negligence or otherwise shall not, in any case exceed the amount of Product needed to replace Product which is proven defective. Upon the Warranty End Date shown above all such liability of Momentive shall terminate.

THE FOREGOING SHALL CONSTITUTE THE SOLE AND EXCLUSIVE REMEDY OF THE OWNER AND THE SOLE AND EXCLUSIVE LIABILITY OF MOMENTIVE. THE WARRANTIES STATED IN THIS PARAGRAPH ARE IN LIEU OF ALL OTHER WARRANTIES (EXCEPT OF TITLE) WRITTEN OR ORAL, STATUTORY, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR PURPOSE.
